**2. Mail in Registrations - Mail completed form and invoice to rebate centre. Expected reimbursement 6-8 weeks after receiving documents.**

Mail all documents to the rebate centre via Canada Post mail, Canada Post Xpresspost, or courier (fax or email does not qualify).

Note: Retailer invoice/receipt (credit card receipt does not qualify) must have detailed information such as tire model and rim size, invoice number, sale price, retailer name and complete address to qualify.

A clear copy of the invoice must accompany ALL rebate claims.
